PARTICIPANT AGREEMENT, RELEASE AND ASSUMPTION OF RISK

In consideration of the services of Tracey J Miller D.B.A. Tug Hill Ridgerunners LLC, their agents, owners, officers, volunteers, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "THR"), I hereby agree to release, indemnify, and discharge THR, on behalf of myself, my spouse, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that my participation in Snowmobile activities entails known and unanticipated risks that could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity.

The risks include, among other things: riding on uneven snow covered terrain; changing snow conditions and variations in elevations; transmissible pathogen or disease; loss of control of the snowmobile; falls from the snowmobile; passengers can be jolted, jarred, bounced, thrown about and otherwise shaken during rides; collision with other snowmobiles, participants, trees, rocks, and other manmade or natural obstacles; snowmobiles are slippery when wet and accident can occur while getting on and off; pinches, bruises, abrasions, strains, burns, cuts and lacerations; exhaustion; major injuries are a risk as are musculoskeletal injuries including head, neck, and back injuries; injuries to internal organs; the negligence of participants, or other persons who may be present; steepness of slopes, snow depth, instability of snow pack or varying and difficult weather; exposure to temperature and weather extremes which could cause hypothermia, frostbite, frostnip, hypoxia, sunburn, or dehydration; encounters with animals and wildlife; altitude sickness, high altitude pulmonary edema; exposure to potentially dangerous wild animals, insect bites, and hazardous plant life; further, passengers can be thrown off the vehicle which can result in any of the above events occurring; equipment failure and mechanical and/or equipment problems; accidents or illness can occur in remote places without medical facilities; improper lifting or carrying; my own physical condition, and the physical exertion associated with this activity. Traveling to and from activity locations raises the possibility of any manner of transportation accidents.

Furthermore, THR personnel have difficult jobs to perform. They seek safety, but they are not infallible. They might be unaware of a participant's fitness or abilities. They might misjudge the weather or other environmental conditions. They may give incomplete warnings or instructions, and the equipment being used might malfunction.

- 2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks. I agree to wear a properly fitted and secured helmet while participating in this activity.
- I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless THR from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of THR's equipment or facilities, including any such claims which allege negligent acts or omissions of THR.
- Should THR or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
- I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I
- In the event that I file a lawsuit against THR, I agree to do so solely in the state of New York, and I further agree that the substantive law of that state shall apply in that action without regard to the conflict of law rules of that state. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining document shall remain in full force and effect.

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against THR on the basis of any claim from which I have released them herein. I also agree that this document is valid for subsequent visits and participation at THR. I have had sufficient opportunity to read this entire document. I have read and understood it, and I agree to be bound by its terms.

PROTECTIVE RIDING HEADGEAR REFUSAL AGREEMENT

I, for have been fully warned and advised by Tracey J Miller D.B.A. Tug Hill Ridgerunners LLC (hereinafter collectively referred to as "THR"), that we should purchase and/or wear a properly fitted and secured helmet while riding or being around snowmobile's (whether on the premises of THR or off the premises) in order to reduce the severity of some of our head injuries and to possibly prevent my/our death from happening as the result of a fall(s) or any other occurrence associated with this activity. We realize that we are subject to injury from this activity and that no form of preplanning can remove all of the danger to which we are exposing ourselves. Against the advice of THR, the guide/instructor, numerous court cases and THR's insurance company, we are refusing this critical safety precaution. I also understand that minors are not allowed to refuse protective headgear and I cannot sign in their behalf to waive the requirement.

- Don't drive faster than you're comfortable with, the maximum speed limit on the trails is 55 mph.
- Don't drive on bare roads, stay on the snow.
- Simply try not to hit anything, it is very costly!
- 8 hour rental time 9-5, \$40 per hour for the first 3 hours over, once you hit 4 hours over your 8 hour rental time you will pay for another full day rental!
- Machines are not permitted for Old Forge.
- The sled must be back before dark.
- If you ride on the road back to the motel, and not the trail, you will be charged for all damages which includes carbides, slides, skis, track, and labor which is around \$2,000.

IMPORTANT NOTICE:

If you cause extensive damage to the snowmobile you will have the option to buy the snowmobile outright at the owner's value or pay for the repair to the snowmobile.
